FRIENDS OF ST MICHAEL'S CHURCH The Parish of Three Saints

In 2012 the three ecclesiastical parishes of Brent Knoll, East Brent and Lympsham combined to form a new single parish, The Parish of Three Saints. This required the establishment of a new framework for managing Church affairs within the Parish. Our funds are divided into two broad streams:

- **Church Life Fund** that provides us with our Vicar and supports the general running of the Church
- Heritage Fund that supports the maintenance, repair and improvement of our three Church buildings

Contributions from people who attend Church regularly and income from specific services, such as weddings and funerals, provide the major part of income for **Church Life**.

We believe that maintaining a local Church in each of the three principal villages of the Parish is important. Not only does it provide a centre for Christian worship but it can also act as a focal point for village life. We also believe in the continuity of our Christian heritage, and hope that this is an idea that all in our villages can share. The **Heritage Fund** provides an opportunity for everyone to support our three Churches within our local Parish community.

The **Friends of St Michael's** is run by local people in Brent Knoll with administrative support from the Parish Office. The Friends will work with the Parish Buildings Team to ensure that funds are available for repairs and improvements to St Michael's Church. If you become a **Member** by regular **annual subscription**, you will receive a twice yearly newsletter that details what is happening to the Church. You will also be entitled to attend our annual meeting and hear about developments at first hand. If you wish to become a **member** of our Friends please complete the application form opposite.
